NOTICE OF RACE

Enoshima Yacht Harbor, Fujisawa, Kanagawa, Japan

The Organizing Authority is Japan Sailing Federation (JSAF).

The regatta is managed by the Kanagawa Prefecture Sailing Federation (KPSF).

1. RULES

- 1.1. The regatta will be governed by the rules as defined in The Racing Rules of Sailing (RRS).
- 1.2. RRS Appendix P, Special Procedures for Rule 42, will apply.
- 1.3. In all rules governing this regatta:
 - 1.3.1. [SP] denotes a rule for which a standard penalty may be applied by the race committee without a hearing or a discretionary penalty applied by the International Jury with a hearing; and
 - 1.3.2. [NP] denotes a rule that shall not be grounds for protests by a boat. This changes RRS 60.1(a).
- 1.4. RRS 63.7 is changed to read: If there is a conflict between rules, the protest committee shall resolve that conflict in the manner that it believes will provide the fairest result on all boats affected.
- 1.5. If there is a conflict between languages, the English text will take precedence.

2. [DP] [NP] ADVERTISING and BOW NUMBERS

2.1. Boats may be required to display bow numbers and advertising chosen and supplied by the organizing authority.

3. ELIGIBILITY AND ENTRY

3.1. Only current fully paid members of their Member National Authorities or one of their affiliated organizations may participate.











- 3.2. Only crews in good standing with the relevant International Class Associations may participate; each crew member shall be a member of the National Class Association affiliated to his/her Member National Authority or of its International Class Association when there is no National Class Association in the concerned country.
- 3.3. Entry method:
 Competitors shall enter by completing the entry form on the event website http://www.jeow.org/
 and paying the required fees.
- 3.4. An entry form filled out completely and the fees shall be received by the Organizing Authority no later than 24:00, 30th September 2019 (Japan Time, GMT+9).
- 3.5. Entries sent after the deadline indicated above, but within 7 days of the start of the Event, will be accepted with the required Entry Fees. After that the entry will be a late entry and the entry will be accepted only at the discretion of the Organizing Authority, whose decision shall be final.
- 3.6. Coaches, team leaders and representatives from participating nations are requested to fill out and submit in the entry form posted on http://www.jeow.org/ within 7 days of the start of the Championship. After that the entry will be a late entry and the entry will be accepted. Coaches' entry fees are requested to be paid in cash upon registration. (Refer to 4.1).
- 3.7. The regatta is open to boats competing in the following events.

3.8. When the number of the entries is less than 10 boats, the event of the class will not be held.









4. FEES

4.1. Fees are stated in JPY and include any local taxes. Entries received and paid by 30th September 2019 will qualify for the early Entry fee. Entries submitted by within 4days of the start of the regatta and paid will be eligible for a late entry fee.

- 4.2. Entry fees will not be refunded.
- 4.3. Entry fees include welcome party fees.
- 4.4. Other fees Harbor usage fee shall be paid by competitors.
- 4.5. Entry fees for **Non-Japanese Competitors** are accepted to be paid online **by PayPal**.

 PayPal: Payments received by PayPal will be charged an additional fee to cover the PayPal administration fees.
- 4.6. Entry fees for **Japanese Competitors** are accepted to be paid **by Bank Transfer**. Bank Transfer: All bank charges must be paid by the competitor.

5. FORMAT

5.1. If the regatta has less than 40 entries in each class, then it will be competed in one single fleet. The final format will be published as an Appendix to the Sailing Instructions.

6. SCHEDULE

6.1. The schedule, including registration, equipment inspection and racing, is as follows:

- 6.3. On the last day of racing for each event, no warning signal will be made after 1330.
- 6.4. No more than 4 races shall be sailed each day.

7. [DP] [NP] EQUIPMENT INSPECTION

- 7.1. Each boat in the 470 and 420 classes shall present a valid measurement certificate.
- 7.2. In accordance with RRS78, competitors are responsible for maintaining their boat in accordance with the Class Rules (for the purpose of RRS78, competitors are considered to be the owners). Equipment checks will be performed at random during the regatta.









7.3. A Technical Committee shall be appointed in accordance with RRS 92.

8. SAILING INSTRUCTIONS

Sailing Instructions will be available during registration at the Race Office and at the event website. Other documents governing the event will be published with the Sailing Instructions.

9. VENUE

9.1. The regatta will be at Enoshima Yacht Harbor. NoR Appendix 1 shows the location of the regatta harbor

9.2. NoR Appendix 2 shows the location of the racing areas.

10. THE COURSES

The courses will be Trapezoid or Windward/Leeward.

11. PENALTY SYSTEM

For the Men's and Women's Skiff events, RRS 44.1 and RRS P2.1 are changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

12. INTERNATIONAL JURY

Events, an International Jury will be appointed in accordance with rule 91(b). Its decisions will be final as provided in RRS 70.5.

13. SCORING

- 13.1. The Low Point System of RRS Appendix A will apply. RRS B8 is deleted.
- 13.2. One race is required to be completed to constitute a regatta.
- 13.3. When fewer than three races have been completed, a boat's series score will be the total of her race scores.
- 13.4. When three or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

14. [NP] [DP] SUPPORT PERSON BOATS

- 14.1. All Support Person boats shall be registered (Refer to 3.6) with the Organizing Authority and, will be required to comply with local legislation and event support boat regulations. The Organizing Authority may refuse registrations and accept late registrations at their sole discretion.
- 14.2. Registered Support Person boats shall act as assistance / rescue boats in case of need and shall comply with any instruction given by the Race Committee or the Organizing Authority.









- 14.3. The supporting boat must be in third party liability insurance (personal liability insurance and passenger accident insurance).
- 14.4. All drivers of support boats must carry a license. Please refer to "Guide for Operator Card and Boat Inspection" on limited license for non-residents.

15. [NP] [DP] BERTHING

Boats shall be kept in their assigned places in the boat park.

16. [DP] RADIO COMMUNICATION

Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

17. PRIZES

Medals will be awarded to the top 3 boats in each event. The Organizing Authority may alter prizes if less than 15 boats are entered in an event.

18. [DP] [NP] MEDIA RIGHTS, CAMERAS AND ELECTRONIC EQUIPMENT

- 18.1. By participating in an event of the ASAF Sailing Cup JSAF Enoshima Olympic Week 2018 competitors automatically grant to the Organizing Authority, Japan Sailing Federation, their sponsors the right in perpetuity to make, use and show, from time to time at their discretion, any motion pictures and live, taped or filmed television and other reproductions of the athlete during the period of the competition without compensation.
- 18.2. Boats may be required to carry cameras, sound equipment and positioning equipment as specified and supplied by the Organizing Authority and in accordance.
- 18.3. The top three competitors as well as the individual race winners may be required to attend a media press conference each day.
- 18.4. Competitors may be required for interviews at the regatta.

19. DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The Organizing Authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

20. INSURANCE

Each participating boat shall be insured with valid third party liability insurance with a minimum cover of one hundred million yen per incident or equivalent.








21. DOPING CONTROL

Doping control will be conducted in accordance with the World Anti-Doping Code. In-Competition testing may be carried out at the venue. Japanese competitors under the age of 20 must be subject to the parental authority of the agreement for the doping testing submitted to the Japan Sailing Federation. Standard format may be obtained from the website of the Japan Anti- Doping Agency or the event website.

21. [DP] [NP] MEDIA RIGHTS, CAMERAS AND ELECTRONIC EQUIPMENT

- 21.1. By participating in an event of the ASAF Sailing Cup JSAF Enoshima Olympic Week 2019 competitors automatically grant to the Organizing Authority, Japan Sailing Federation, their sponsors the right in perpetuity to make, use and show, from time to time at their discretion, any motion pictures and live, taped or filmed television and other reproductions of the athlete during the period of the competition without compensation.
- 21.2. Boats may be required to carry cameras, sound equipment and positioning equipment as specified and supplied by the Organizing Authority and in accordance.
- 21.3. The top three competitors as well as the individual race winners may be required to attend a media press conference each day.
- 21.4. Competitors may be required for interviews at the regatta.

> Guide for Operator Card and Boat Inspection

License, inspection and registration are required for the support boats/drivers in Japan. However, overseas teams may be exempted from such requirements during the limited period (Oct 2016 – Aug 2020) for driving in the <u>Navigation area</u> by obtaining an "Operator Card" (for exemption of driver license) and a "Certificate Sticker" (for exemption of boat registration)

[Operator Card]

The operator card will be issued by the Japanese Government (MLIT), through JSAF. Applicants should prepare the documents below. (It will take 30 days to issue the card.)

- ① Application form (with signature)
- 2 Photo (No cap / sunglasses)
- ③ Countries with driving license system => Copy of the license Countries without driving license system => Endorsement from MNA and a copy of passport The cards will be given at Enoshima directly to the driver.

[Boat Inspection - Non Japanese Registration]

The Boat Inspection will be issued by the Japanese Government (MLIT), through JSAF.

Applicants should apply at least 30 days before the estimated arrival date of the coach boats.

Please prepare the copy of boat inspection if you have one.

JSAF will issue a "Certificate Sticker" after checking the boat in Japan.


